AND WHEREAS according to the terms of said agreement, it has been stipulated that payment of Rs. 5,00,000.00, provided that the agent furnishes to the KINEXIN a Bank Guarantee from a recognized bank, acceptable to the KINEXIN, valid for a period covering full the Guarantee Period as per the Conditions of the agreement, being the conditions attached to and forming part of the said agreement.

4. That in consideration of the promises and at the request of the said agent, we hereby irrevocably undertake and guarantee to pay to the KINEXIN Convention Management Pvt. Ltd. or at such other place as may be determined by you forthwith on demand and without any demur, any sum upto a maximum amount of ----- in case the agent make default in paying the said sum or make any default in the performance, observance or discharge of the guarantee contained in the said agreement.
5. We agree that the decision of the KINEXIN, whether any default has occurred or has been committed by the agent in the performance, observance or discharge of the guarantee aforesaid shall be conclusive and binding on us M/s. ----- --.
6. KINEXIN shall be at liberty, from time to time, to grant or allow an extension of time or give other indulgence to the said agent or to modify the terms and conditions of the agreement with the said agent without affecting or impairing this guarantee or our liability hereunder.

7. We undertake to pay to the KINEXIN any money so demanded notwithstanding any dispute or disputes raised by the agent in any suit or proceeding pending before any Court or Tribunal relating thereto our liability under this present being absolute and unequivocal. We also undertake to pay to the KINEXIN any money so demanded against the KINEXIN's claims in any other contracts placed on the said agent.

The payment so made by us under this bond shall, be a valid discharge of our liability for payment thereunder and the agent shall have no claim against us for making such payment.

8. This bank guarantee comes into force from the date of agreement establishment (Dt. \_\_\_\_\_ and will remain in full force and effect up to \_\_\_\_\_ . ( viz till the date of expiry of the warranty period as per of the agreement).
9. This guarantee will not be discharged due to the change in the constitution of the Bank or the Sellers.
10. That no claim under this guarantee shall be entertained by us unless the same has been preferred by the KINEXIN within the said date.
